The General Tariff

What is an event, festival or theatre play without music? Music is what makes the atmosphere. It draws in visitors, can boost the sales and sets the tone for any occasion. To ensure composers and lyricists can continue to make music you have to pay a fee to use music.

We calculate this fee as follows

The fee is a percentage of the receipts. The receipts are the total income from entrance prices, subsidies, donations, sponsor money and other income regarding the event. The applicable VAT is deducted from the total amount. When there are no receipts, or the receipts are less than the total amount of (the) wage(s) and/or the buy-out fee(s) you pay out to the performing artist(s), a percentage of the wage(s) and/or buy-out fee(s) is applied. A floor area price is always used as a minimum fee: (see table on the back of this flyer).

Share Buma protected world repertoire

Percentage of the receipts or wage(s)/buy-out fee(s)

- *Events in the open air.*
We apply a minimum floor area of 700 m² for open-air events.

- *Film shows and other audio-visual presentations in (movie) theatres and any similar accommodations.* You pay 6% of the receipts with a minimum per show/presentation based on the floor area of the location (see table on the back of this flyer). The General Tariff applies if film footage is shown during a musical performance.
- *Carillon music.*
Price per performance: € 9,87. Yearly price for automatic performance: € 501,28.

Please note!

- Different tariffs apply for music use in restaurants & bars, work spaces and other specific music use. Ask for our tariff overview or visit bumastemra.nl/en.
- Organize the music use with Buma ahead of time. Otherwise you do not have permission and Buma can charge you a supplement of 50% of the fee owed, with a minimum of € 25.

For every extra 50 m², or part of that, a surcharge of € 3,78. The minimum for a musical performance in the open air is equal to the fee for 700 m², or € 76,19.
